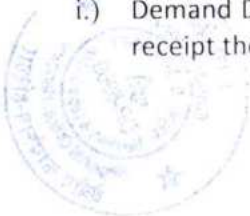

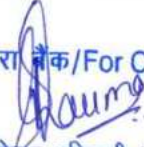




Special Instruction/Caution
