

Fuel Cashback Offer

- 1.1. **Eligibility Criteria:** The offer is only applicable for the inactive Canara Credit Cards who have been intimated by the Canara Bank about the applicability of the “fuel cashback” offer through SMS/WhatsApp.
- 1.2. Eligible Canara Credit Card holders to do the fuel filling from any nearby authorized fuel station.
- 1.3. Eligible Canara Bank Credit Card Customers will get a cashback of Rs.100/-, and the same will be adjusted against their Credit Card bill within 60 days from the end date of the offer.
- 1.4. The offer is valid from 03.07.2026 to 31.07.2026.
- 1.5. The offer will be applicable on fuel Merchant Category Code (MCC).
- 1.6. First 50,000 customers based on transactions date and time, will be provided with the cashback.
- 1.7. Offer is available to selected Canara Credit Card Customers only.

- 1.8. The offer will be applicable to Canara Credit Card customers as per the criteria defined by Canara Bank.
- 1.9. Any person availing this Offer shall be deemed to have accepted these terms and conditions.
- 1.10. The offer is applicable only for payment done through Canara Bank Credit Card at any authorized fuel station.
- 1.11. The above Offer is by way of a special offer for Canara Bank Credit Cards holders only, as per criteria determined by the Bank at its sole discretion.
- 1.12. Canara Bank reserves the right to disqualify the Cardholder(s) from the benefits of the Offer, if any fraudulent activity is identified as being carried out for availing the benefits under the said Offer or otherwise by use of the Credit Card.
