

Fuel Cashback Offer

- 1.1. This “Fuel Cashback” offer is applicable only to Canara Credit Cards which are newly issued between 01.05.2026 to 30.06.2026, and are yet to be activated, and such cardholders who have been specifically intimated by Canara Bank regarding the applicability of the “Fuel Cashback Offer” through SMS and/or WhatsApp communication.
- 1.2. The offer is valid from 03.07.2026 to 31.07.2026.
- 1.3. Eligible Canara Credit Card holders have to activate their card by generating Green PIN and have to do the first financial transaction of Rs.100 & more at any authorized fuel station using the newly issued Canara Bank Credit Card.
- 1.4. Eligible Canara Bank Credit Card Customers will get a cashback of Rs.100/-, and the same will be adjusted against their Credit Card bill within 60 days from the end date of the offer.
- 1.5. The offer will be applicable on fuel Merchant Category Code (MCC).
- 1.6. Add-On & Corporate Cards are not eligible for the offer.
- 1.7. First 50,000 customers based on transactions date and time, will be provided with the cashback.
- 1.8. Offer is available to selected Canara Credit Card Customers only.

- 1.9. The offer will be applicable to Canara Credit Card customers as per the criteria defined by Canara Bank.
- 1.10. Any person availing this Offer shall be deemed to have accepted these terms and conditions.
- 1.11. The offer is applicable only for payment done through Canara Bank Credit Card at any authorized fuel station.
- 1.12. The above Offer is by way of a special offer for Canara Bank Credit Cards holders only, as per criteria determined by the Bank at its sole discretion.
- 1.13. Canara Bank reserves the right to disqualify the Cardholder(s) from the benefits of the Offer, if any fraudulent activity is identified as being carried out for availing the benefits under the said Offer or otherwise by use of the Credit Card.

The Canara Bank reserves the right, at any time, without prior notice and without assigning any reason whatsoever, to add/alter/modify/change or vary these terms and conditions or to replace, wholly or in part, this offer by another offer, whether similar to this Offer or not, or to extend or withdraw it altogether.
