SUBMISSION OF LIFE CERTIFICATE FOR THE YEAR 2026-27

All Ex-employee pensioners / Family pensioners are required to submit their Life certificate (LC) for the year 2026-27, in the month of November from 01.11.2026 to 30.11.2026, for continuation of disbursement of monthly pension. Life Certificate can be submitted through any of the following online & offline channels:

1. Jeevan Pramaan portal / UMANG App
2. Physically at any of our Branches
3. Doorstep Banking services

LINKING OF AADHAAR WITH PAN

As per Section 139AA of Income Tax Act 1961, every person eligible to obtain Aadhaar and has PAN, must link his / her Aadhaar with PAN. If PAN is not linked with Aadhaar, higher TDS is being deducted from the monthly pension of such ex-employee pensioners. The list of pensioners whose Aadhaar is not linked to the PAN has been uploaded in our website under Ex-Employees page. Hence, such pensioners are requested to link their Aadhaar with PAN expeditiously.

It has come to our notice that fake pensioner card application links/ calls/ SMS claiming issuance of pensioner card, are being sent to Canara Bank ex-staff pensioners. Fraudsters are using AI generated images with Bank logo offering attractive benefits, exclusively for ex-staff pensioners. Please be advised that Bank do not have any such debit/credit card variants solely for ex-staff pensioners. Beware of such fake application links, calls and SMS. Bank does not seek any personal / account details in this regard.
